Let us end the shame and restore our nation's moral compass by ensuring that all children, regardless of their immigration status, are treated with dignity and respect.

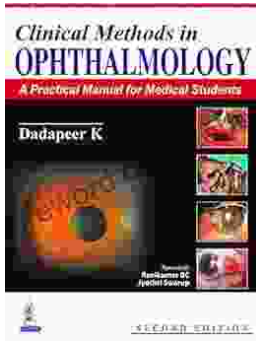
